

## **NEW TELEMEDICINE TENDER. GPI AMONG THE WINNERS. TECHNOLOGY FOR MORE ACCESSIBLE HEALTHCARE**

Trento, 05 September 2024

The Temporary Grouping of Companies (“RTI”), of which Gpi is the agent, has been named as one of the winners of the two lots of the tender launched by Aria S.p.A - The Regional Agency for Innovation and Procurement of Lombardy (Italy) -, concerning the Framework Agreement for the award of the Regional Telemedicine Infrastructure service. The aim is to equip all Italian regions with a Telemedicine system that strengthens the technological infrastructure and tools for data collection, processing, and analysis through the enhancement of the Electronic Health Record (“FSE”).

The total amount of the two lots amounts to € 279 million, the RTI of which Gpi is the agent will benefit from between € 26.5 million and € 53.1 million and Gpi's share is equal to 60%. The contract will run for 48 months.

Televisit, Teleassistance, Teleconsultation and Telemonitoring services will be activated. This means, for example: healthcare can be received at a distance; remote sensing and transmission of vital and clinical parameters via biomedical sensors; and improved home care. It will also enable health workers to adopt new processes to collaborate better with improved organisation.

Within this large project, Gpi will be one of the key partners to enable operational models aimed at improving quality of care, costs and more generally the healthcare experience of citizens. A cutting-edge project that will be based on requirements for interoperability with the national cloud-based infrastructure, security and privacy. The project will bring flexible and scalable technologies in line with market best practices into Italian healthcare facilities. It will thus be possible to guarantee the automation of clinical and infrastructural processes in every single operational context.

Once again, Gpi proves to be a reliable partner to tackle the most innovative challenges in terms of digitisation of the national health system. This tender will provide an opportunity to develop technological solutions that have the potential to reduce geographical disparities through equitable and widespread access to health services. In a context of ever-increasing chronic diseases, Gpi will contribute with its telemedicine solutions to the sustainability of the healthcare system. A new way of meeting the need to balance physical distance with continuity and quality of care.
