



# GPI AMONG THE FIRST ITALIAN COMPANIES TO BE CERTFIED UNDER ISO 42001 FOR AI MANAGEMENT

Gpi announces that **it has obtained ISO/IEC 42001 certification**, the new international standard dedicated to Artificial Intelligence (AI) management systems. In the field of healthcare software applications GPI is among the first in Italy, the ninth in Europe and the 54th in the world. The certificate was issued by DNV, an independent third-party body, confirming the Group's commitment to compliant, transparent and safe use of AI.

Artificial intelligence introduces new challenges that require solid tools for responsible management. ISO 42001 is a **benchmark for organisations designing and integrating artificial intelligence systems**, covering aspects such as risk management, data quality, transparency, and observance of fundamental rights. For Gpi, active in the development of AI solutions to support clinical, diagnostic and management pathways, this result consolidates a path that combines technological strength and adherence to regulatory requirements.

This certification ensures that the development and use of artificial intelligence is carried out responsibly, safely and consistently with the Group's values. A choice that reinforces Gpi's commitment to responsible innovation at the service of healthcare.
